

As an international student, you will need to check whether you need a visa to study in the UK. You can do this by visiting gov.uk/check-uk-visa

If you need a visa, you will need to follow the steps outlined below to obtain a CAS and apply for your visa.

Obtaining A Confirmation of Acceptance for Studies (CAS)

A Confirmation of Acceptance for Studies (CAS) will only be issued by the International Office to students with a **GUARANTEED UNCONDITIONAL** offer. You will also be required to pay a **25**% **DEPOSIT** of your tuition fees for 2019/20. You may then request a CAS.

Paying Your Deposit

You must pay RNCM 25% of your tuition fees for 2019/20. If you have been awarded an RNCM scholarship or bursary, please deduct these from the total fees and pay 25% of the remaining figure as your deposit. This deposit will be recorded on the Confirmation of Acceptance for Studies (CAS)

You can pay your deposit by BANK TRANSFER or by DEBIT/CREDIT CARD.

Starting Your Visa Application

While waiting for your CAS to be issued, you can start to prepare your visa application. As soon as the CAS is issued we will send you an e-mail containing the details you will need to complete the application. DO NOT attempt to apply for a Tier 4 Visa without the CAS, the application will be rejected.

Start your visa application by visiting the UK Visa & Immigration (UKVI) website gov.uk/apply-uk-visa

Meeting Your Conditions

Any documents that you will need to provide with your visa application will be listed on the Confirmation of Acceptance for Studies (CAS)

You will also need to prove that you have enough money to pay the remainder of your tuition fees for 2019/20 and an extra £9,135 (equivalent to £1,015/month) to cover accommodation/living costs. These funds MUST be in your bank account (or parents' bank account) for 28 CONSECUTIVE DAYS ending no more than 30 days before the date of your visa application.
